

# Typical Project Roles



#### **Executive Sponsor**

A senior executive that is responsible to the organization for the success of the project.



#### **Project Officer**

Responsible for orchestrating the work on the different workstreams. Manages timeline tracking and monitoring.



#### **Product**

Responsible for overseeing all product-related work that will be done to deploy on Velocity Network.



#### Developer

Responsible for coding the integration of your database to Velocity Network.



#### **Dev Operations**

Responsible for deploying the credential agent in your production environment.



#### DBA

A database expert who understands your DB structure and can map credential fields appropriately.



#### Info Sec

Responsible for security oversight and ensuring that Velocity Network deployment passes internal security checks.



#### Compliance

Responsible for compliance oversight and ensuring that Velocity Network deployment adheres to internal compliance policies.



#### **Quality Assurance**

Responsible for building and executing a robust end-to-end testing plan that accounts for the effect of novel technology on user behavior.
